- At least 5 years' experience (master's degree) or 7 years' experience (with bachelor's degree) in biodiversity finance, environmental finance, sustainable finance, public finance, economic analysis, natural resource economics, environmental policy, public administration, budget analysis, costing, or other related fields relevant to biodiversity finance planning and financial needs assessment.
