ANNEX 1: SCHEDULE OF REQUIREMENTS (Terms of Reference)

A. Summary of Requirements

Requirements are comprised of the following services:

- Warehouse sorting and allocation of all required furniture items for each school in accordance with Annex B.
- Transportation of the specified quantities of furniture items to each school in accordance with Annexes B and C.
- On-site assembly of furniture items in accordance with the manufacturer's instructions in accordance with Annexes A, B, and D.
- Installation of the assembled furniture items, including positioning cabinets in their final designated locations, in accordance with Annexes 5A, 5B, and 5C.
- All handling and portage services shall be provided by the selected company.

B. Background

In 2024 – 2027, UNDP and UNICEF jointly implement the “Advancing Quality Education and Lifelong Learning Opportunities for All” project funded by the European Union. The project's overarching objective is to contribute to human capital development in the Republic of Moldova, improving the quality and relevance of education and lifelong learning opportunities for all to match the labour market demands better. To achieve this, the Programme will target the following specific objectives:

1. Strengthen institutions and systems for teacher and school leader professional development and support the implementation of education policies to enhance the quality of teaching and learning (Development Strategy “Education 2030”).
2. Improve equitable access for all children to quality education, promoting the development of an inclusive, digital, and resilient education system.
3. Upgrade learning environments by renovating selected school infrastructures and facilitating the development of 21st-century skills, contributing to better education opportunities for pupils and students and improved efficiency of the school network.

Under this joint Project, UNDP will support the Ministry of Education and Research to ensure equitable access for all children to quality education and, therefore, to schools, particularly in rural areas and less accessible communities. Many rural school facilities are so outdated that they fail to meet basic sanitation and hygiene standards. Rural students have limited access to their schools' water, sanitation, and hygiene facilities. This fragmentation impacts student performance, as evidenced by the 2022 PISA results showing significantly better outcomes in larger schools compared to smaller predominantly rural ones.

In response, the Ministry of Education and Research (MER) is focusing on optimizing the school network by transforming larger district schools into Model Schools. Thirty-five schools, one per district/municipality, are targeted to serve as Model Schools, featuring modern infrastructure, high-quality teaching staff, modern equipment, inclusive management, and school buses for transportation.

At this stage, UNDP Moldova proposes to equip science laboratories (chemistry, physics, biology, and mathematics) with student desks and chairs, as well as cabinets. The Project Team has already procured the earlier mentioned furniture items and seeks to contract a qualified service provider to carry out the sorting, transportation, assembly, and installation of the furniture for nine beneficiary schools. The attached Annexes to this TOR will serve as the basis for defining the scope, quantities, technical

requirements, and locations for the sorting, transportation, assembly, and installation of the furniture items. The winning company shall complete all deliverables in accordance with Annexes A, B, C, D, 5A, 5B, and 5C **within a period of 7-10 calendar days, by January 11, 2026.**

C. Scope and objectives of the contract

The scope of the contract includes services of sorting, transportation, assembly and installation of furniture items according to the requirements detailed in Annexes A, B, C, D, 5A, 5B, 5C.

D. Delivery

UNDP Moldova is looking for a maximum delivery time of **7-10 calendar days** for sorting, transportation, assembly and installation of the furniture items from the signature of the contract. Delivery locations are specified in Annex C.

F. Deliverables

The bidder will submit the bid for all services in accordance with all Annexes of this ToR (A, B, C, D, 5A, 5B, 5C). Deliverables will be provided as per the table below.
